The Executive Committee of the Covenant Region CPWM met on August 24, 2012 at the Fredonia Church.

President, Sidney Milton opened the meeting with prayer.

The budget was discussed and agreed upon at the beginning of the meeting.

The Committee made plans for the Fall Meeting to be held on October 20, 2012 at the Fredonia Church.

There was discussion on the importance and validity of having a Youth Delegate at Convention. It was the general consensus that it would better serve our needs to send two officers to Convention, one as Delegate and the other as the Alternate, and omit sending a Youth Delegate.

Therefore, we make the following recommendation:

Recommendation #1: Eliminate the Covenant Region Youth Delegate to CPWM Convention and reapportion the money budgeted to sending both the President and President-Elect to Convention. In the event either the President or President-Elect is unable to attend, another officer will be chosen to replace her. This action should be added to the Covenant Region Standing Rules.

Another discussion involved questions made to the Executive Committee over the years regarding the need for a Correspondence Committee and a Resolution Committee. The Delegates appointed to these two committees have to spend their lunch break at Regional meeting completing their tasks and are not able to fellowship with the other attendees. It was the feeling the functions of these two committees do not seem to be essential and can be modified.

It was suggested we have greeting cards available at the beginning of the meeting for ladies to fill out and address during the meeting. The Secretary would collect the cards by the end of the meeting and mail them. This would eliminate the need for the Correspondence committee. In regards to the need for a Resolution Committee to say “thank you” to God and our host church at the close of the meeting, it was suggested we allow our President-Elect to do that honor.

Therefore, we make the following recommendation:

Recommendation #2: Item 5 and Item 6 in Section D of Standing Rules for Covenant Region CPWM, regarding Correspondence Committee and Resolution Committee, be deleted. This will eliminate the requirement of appointing these committees at each meeting.
